Alcohol and/or Drug Abuse (AODA) & Weapons Policy

- (1) Students who bring a weapon on school grounds will be terminated from school with no tuition refund.

- by boasting, glamorizing or romanticizing about drugs or alcohol use.
- [3] A student who violates the AODA policy will have his/her status evaluated by the Director in partnership with appropriate staff and parents. The Director will make a decision on further action, which may include suspension and/or termination from the school.

Horizon High School Policy on Urine Drug Screening

All students will undergo a witnessed urine drug screen within 10 days of enrollment in Horizon High School.

At a minimum, the screen should include the following drugs: Opiates, marijuana, cocaine, PCP, amphetamines, barbiturates, benzodiapines and methadone. Students with a history of LSD or ecstasy use should also be screened for those drugs. The drug screen does <u>not</u> have to go through a formal "chain of custody" procedure.

Respect and Kindness Policy

"Everyone is expected to respect everyone else."

A safe and comfortable learning environment is essential at Horizon High School. Respect and kindness are expected of all individuals.

The following types of **Respect** are essential:

- Respect for individuals, both physically and emotionally.
- Respect for individual and school property.
- Respect for racial and cultural diversity.
- Respect for other sexual orientation.

It is important to remember that the action need not be intentional for the Respect and Kindness Policy to be broken.

The person who feels that he or she was disrespected should as a first step talk to the offender. Students are encouraged to talk with their mentors or teachers about any situation regarding this policy.

If the disrespectful actions continue, the parties involved will be asked to engage in a conflict resolution procedure. Continued problems with following the Respect and Kindness Policy could lead to a further verbal warning, parental contact, contact with the community school and/or expulsion from the Horizon High School.

Student Policy, Procedures and Rules for Using Computers and the Internet

There is tremendous potential for learning using the Internet. Vast amounts of information and knowledge are archived there. Major libraries continually add to the amount of material accessible – for free. Additionally, organized educational classes exist online that provide specialized learning opportunities. But at the same time, there is also much potential for wasted time as well as opportunities for poor judgment.

There will be no email accessing, no instant messaging and no participating in chat rooms, on Horizon High School computers, without the express written authorization of the teacher. There will be no downloading of software, games, music or pornography. Failure to follow these rules will result in loss of computer privileges, and could result in dismissal from Horizon High School.

It is the policy of the Horizon High School Board of Directors to mandate and expect that students will use the Internet in a responsible manner. Accordingly, the Board has established a policy and procedures for the use of the Internet along with rules governing the behavior of students who access the Internet. Students who do not comply with the standards of behavior outlined in the student conduct and discipline plan or with the Internet rules below will lose their privilege to use the Internet and/or be subject to other disciplinary action.

Students have 2 privacy expectations for their computer usage history and for the contents of their files on the Horizon High School computers: a limited privacy expectation from HHS staff and board, and a high privacy expectation from other students. Storage areas (hard disks) on computers may be treated like school lockers. Horizon High School staff may access student files on hard disks both for routine maintenance and if there are indications of improper usage.

Procedures For Use:

1. Horizon High School will allow every student access to the Internet provided parents or legal guardians of students do not object in writing to a student's having such access.

- 2. Each year, prior to use, each student shall receive and discuss information from his/her teacher regarding:
 - a. Internet safety and security, including:
 - the importance of understanding what materials are inappropriate to minors
 - safe use of electronic mail, chat rooms and other direct forms of electronic communication including the importance of understanding that one should never provide personal information to a site on the Internet without the supervision of an adult; such personal information includes full name, address, phone number, credit card number, and Social Security number
 - b. Responsible use of the Internet, including
 - abiding by copyright laws
 - understanding that unethical and unlawful activities include unauthorized access to any data or communications equipment without the owner's permission, "hacking," or unauthorized disclosure, use, or dissemination of anyone's personal information

Rules:

1. Students shall:

- a. Use Horizon High School computers and Internet access only for researching materials directly related to their school assignments
- b. adhere to the same standard of conduct expected and required in a classroom
- c. follow rules for creating and using only their own individual user accounts with passwords
- d. follow rules for using resources, time limits and printing instructions
- e. log off as soon as finished to provide others with the opportunity to use the computer/ access the Internet
 - f. report violations of these rules

1. Students shall not:

- a. Access email, engage in instant messaging or participate in chat rooms the only exception shall be where class work requires email and only under conditions explicitly authorized in by the teacher (in writing optimally).
 - b. Download software, games, music or pornography
 - c. Log in to another user (school, MCC)1 account
- d. lend their user account logins and passwords to anyone else
- e. create a computer virus and place it on the computer or network

- f. send a message that is inconsistent with the school's code of conduct, written or implied
- g. send messages that are inappropriate, obscene, racist, sexist, homophobic, contain obscenities, or contain inflammatory or abusive language
 - h. send any message with someone else's name on it
- i. read mail or files without the owner's permission, nor view other's computer desktops/screens remotely
- j. interfere with the ability of other users to make effective use of Horizon High School's computing and network resources
- k. burn any material onto cds/dvds the only exception shall be where class work requires this and only where explicitly authorized by the teacher.
